DIRECTIONS

Preparation:

1. Sweep or dust mop the floor to remove debris.
2. Dilute concentrate between 1:4 and 1:8 ratio with cold water, depending on the age and build up of finish. (1:4 ratio is stronger and will have quicker results).
3. Apply diluted product generously with a mop to an area small enough not to allow the solution to dry. Diluted product must cover the finish entirely to be completely removed.

Rinse thoroughly with cold, clean water to remove any residue before application of finish.

NOTE: Always test in an inconspicuous area. Some flooring may be affected by stripper in higher concentration levels.

Contains: Monethanolaminine, Propylene Glycol Butyl Ether, Surfactant Blend, Water.

In Case of Spill: Clean up immediately. Place container in well ventilated area. To clean up spill, flush area with large quantities of water. Avoid run-off into storm sewers and ditches leading to natural waterways.
