## DIRECTIONS

1. **Laundry Stains & Odors**—use straight: Pre-spray stains and allow to work up to 15 minutes dwell time. Run through regular washing cycle. Repeat if stains persists, before drying.
2. **Carpeting—Pet & Organic Stains**—1 to 2 parts water dilution. Spray or pour mixed solutions penetrating carpet backing. Lightly tap area with brush. Blot with clean, absorbent blotter, removing as much of the spot substance as possible. Keep moist for 24 hours. Repeat procedure if necessary.
3. **Upholstery—Organic Stains**—use straight: Clean stained area with damp sponge. Apply solution sparingly. Allow up to 15 minutes dwell time. Blot excess with clean, dry towel.
4. **Restrooms—Urine Odors**—1 to 2 parts water dilution. Spray mixed solutions around toilets, back walls and floors. Allow to dry.
5. **Drains—Food Odors**—use straight: Pour 2 to 4 oz. straight solution into drain whenever odor becomes a problem.
6. **Tile & Concrete Floors—Organic Stains & Odors**—use straight: Spray or mop onto floor area and allow to dry.

**Do Not Mix with Bleach or use in conjunction with any household products.**

## HARMFUL IF SWALLOWED.

**Ingredients:** Water (CAS#7732-18-5), Propylene Glycol n Butyl Ether (CAS# 5131-66-8), Proprietary blend of multiple complex enzymes, 1, 2, Propanediol (CAS# 57-55-6), Sodium Dodecyl Sulfate (CAS# 151-21-3).

## PROTECT FROM FREEZING.
