DIRECTIONS

Before Cleaning:

Test on surface before using. Apply a small amount of product to an inconspicuous area. If surface mars, dulls, discolors, fades or fiber color transfers to a white cloth, do not use.

Do not use silk, satin, velvet, leather, suede, latex, painted or varnished wood surfaces. May dull some plastics.

Carpet & Upholstery:

1. Apply **Unbelievable® Rust Spot'R™** directly to stained area.
2. Use 3-in-1 spotting tool or brush to work into stained area.
3. Blot with an absorbent, clean, white, towel.
4. Repeat until stain is removed.

Laundry

1. Apply **Rust Spot'R™** as directed for carpet & upholstery steps 1 & 2.
2. Machine wash. If stain persists, repeat.

Tile

1. Remove any wax finish with stripper, thoroughly rinse and dry stained area.
2. Apply **Rust Spot'R™** to stain and allow up to one minute dwell time.
3. Repeat steps if necessary.

Concrete/Natural Stone

1. Thoroughly degrease and rinse area. Blot dry.
2. Apply **Rust Spot'R™** to stain, and allow **no more than 30 seconds dwell time. NOTE:** extended exposure may cause whitening of concrete and/or etching of natural stone.

Do Not Mix with Bleach or use in conjunction with any household products.

HARMFUL IF SWALLOWED.

Ingredients: Water (CAS#7732-18-5), Mixed Phosphate Salts (CAS#7758-29-4, 7320 (CAS#000151213), Sodium Xylen Sulfonate (CAS#1300-72-7), Propylene Glycol & Butyl Ether (CAS#5131-66-8). This product does not contain
