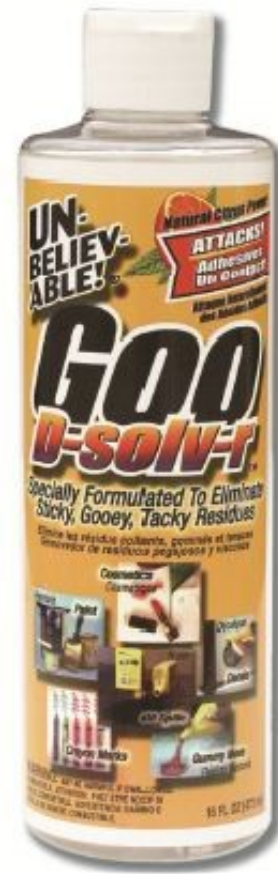

Goo D-Solv-r™ works well with Core's **T-Bone™ 3 in 1 spotting spatula** to remove excess adhesive, tar, gum, wax or other built up matter on material prior to spot treatment.

DIRECTIONS

Before Cleaning:

Test on surface before using. Apply a small amount of product to an inconspicuous area. If surface mars, dulls, discolors, fades or fiber color transfers to a white cloth, do not use.

Do not use silk, satin, velvet, leather, suede, latex, painted or varnished wood surfaces. May dull some plastics.

Carpet:

1. Drip sparingly. Over saturation may cause temporary swelling or delaminating may occur and require re-gluing or re-stretching.
2. Drip apply to spot or stained area. Wait 30-60 seconds.
3. Work product into affected area back and forth with rounded edge of a spotting tool. Gently rub/blot with clean white towel. Gently rub out stain with towel. Blot with a clean, damp cloth.
4. Repeat if necessary.

Upholstery:

1. Apply **Unbelievable® Goo D-Solve-r** directly to a clean, white, towel.
2. Gently rub out stain with towel.
3. Blot with a clean, damp cloth.

Do Not Mix with Bleach or use in conjunction with any household products. MAY BE HARMFUL IF SWALLOWED.

Ingredients: Mineral oils, citrus oils and organic wetting agents; Isoparaffinic solvent CAS# 68551-19-9, d-Limonene CAS# 5989-27-5, Glycol Ether Blend CAS# 5131-66-8, 1582-83-7, 29911-28-2, 57-55-6, 25265-71-8.

In Case of Spill:

- Wear suitable protective equipment. Eliminate ignition sources.
- Contain release by using an inert material such as sand or oil absorbent and/or eliminate the spill source.

- Take up and containerize for proper disposal.
- Do not discharge into sanitary sewer or storm sewer.
- Comply with all state, federal and local regulations.
- Not Regulated except in bulk shipment.
